Presentation and Outdoor demonstration

- Optional activities (Presentation and Outdoor demonstration) are limited and your request will be considered. You will receive a
 confirmation email about optional activities. Translation service is not provided at the Stage and Outdoor area. If your optional
 activity is approved, please be ready to host your session in Japanese.
- No electricity available at Outdoor demonstration.

Internet Connectivity

- If your booth activities rely on Internet connectivity, it is essential that you order the necessary services. A public or rental Wi-Fi network (you need to register or order in advance) might be unreliable for sustained booth activities due to high traffic and interference.
- Those who conduct the presentations and workshops should bring the proper preparations without any Internet connectivity in case of unstable network condition.

Electrical Services

- We will provide the power supply capacity you requested at the time of registration. There is only one power outlet near each table, so please be sure to bring your own "power strip" (no drum reels).
- You cannot use more than the power supply capacity you have applied for. No changes will be accepted after registration.
- Please bring your own voltage converters.

Exhibit

- Basically the space is empty except rental tables, chairs, and an electrical outlet. Please bring the necessary items and equipment by yourself.
- Please note that fabric items (flag, curtain, tablecloth, carpet), plywood for display and other similar goods must be fireproofed due to the Japanese law.
- No exits, fire fighting equipment, or emergency equipment may be blocked or obstructed under any circumstances.
- \cdot $\;$ Please take all of your trash and disposal items home when you leave.

Safety & Prohibited Issues

- All exhibits and dangerous materials you are going to bring must be submitted through this Makers Application Form and/or Final Registration. Describe all possible safety issues. Non-Registered dangerous materials must be removed from the exhibiting spaces.
- Exhibiting with fire (any size of flame) and/or bringing fuel (liquid, gas, etc) on site are prohibited by Japanese law.

List of items requiring application

- 1. Poisonous and Deleterious Substances
- 2. Project which needs high voltage
- 3. Huge project taller than 2.4m
- 4. CNC
- 5. Flying project such as drone, model airplane, balloon
- 6. Projects containing food
- 7. Ceiling structure such as dome, tent
- 8. Project which uses frequencies
- 9. Project which uses liquids such as water
- 10. Living animals and fishes
- 11. Other dangerous materials or tools
- 12. Works using hydrogen
- 13. Alcohol for hand sanitizer with an alcohol weight concentration of over 60%: Alcohol for hand sanitizer with an alcohol weight concentration of over 60% is subject to hazardous materials application to the fire department and fire inspections. If you bring hand sanitizer with a weight concentration of more than 60%, you must meet all of the following requirements. Please be careful.
 - Stored in a container of 500ml or less
 - The volume and ingredients are listed on the container
 - "Refilling" is prohibited in the venue.
- At Maker Faire Tokyo 2023, giving away, selling, or sampling food/beverage (packaged or unpackaged) without organizer's permission is not allowed.
- Management reserves the right to restrict exhibits, displays, demonstrations, presentations, or workshops that become objectionable because of noise, method of operations, materials, safety, or any other reason.

Note

- Applicants of the Companies are also reviewed.
- We do not accept delivery of your artwork or equipment by vehicles, international courier, international mail.

Prohibited items to be brought in venue

- For safety reasons, the following items are prohibited.
 - 1. Lithium-ion battery, Lithium polymer battery
 - 2. Heating tool such as soldering tool
 - 3. Laser equipment such as laser cutter
 - 4. Gasoline, light oil, other flammable liquids
 - 5. Flux cleaner
 - 6. Gunpowder, explosive
 - 3D printer (with inflammable materials such as resin, alcohol and so on) etc.

- You agree to comply with all applicable laws, including Radio Act in Japan, the Maker Application Guidebook, and any other requirements, and/or rules & regulations issued by us in connection with Maker Faire Tokyo. You are responsible for obtaining any permissions required for your performance, distribution, or posting of copyrighted material; for obtaining any necessary licenses and permits; and for payment of all taxes (including sales and use taxes), license fees, or other charges applicable to your participation in Maker Faire Tokyo. We may terminate this Agreement and/or your participation in Maker Faire Tokyo if you violate this Agreement, or the standards of conduct established by us or by the venue proprietor.

Prevention of Infection

This guideline will be revised as necessary based on the future situation of COVID-19 and the guideline of the government, Tokyo Prefecture, etc. We have prepared this in accordance with the policies of the Japan Exhibition Association.

A-1 Basic Policy

We will take measures to prevent the spread of infection by avoiding to make closed spaces, crowded places, close-contact settings. Please note these measures may be added or changed.

A-2 Measures to be taken by Exhibitors (Maker) and Sponsors

- In the case of touching works, products or conducting workshops, disinfect the works, products and equipment etc., as well as the Maker's and participants' hands.
- If you have a fever or feel sick, refrain from coming to the event.
- Do not bring alcoholic beverages into the venue.
